1. One dollar per head MUST be sent in with consignment.
2. Consignment fee forfeited if cattle are not delivered.
3. Commission fee will be \$15.00 per head, for cows \$25.00 per head, and for cow and calf pairs \$30.00 per head.
4. All cattle to be free of apparent disease.
5. All cattle remain the property of the Consignor until sold.
6. All cattle must have been ON THE CONSIGNOR'S FARM 120 DAY OR MORE PRIOR TO THE SALE.
7. Consignor may request the Ass'n. to SELECT DIRECT PEN of 8 or more head of uniform cattle.
8. The Association reserves the right to reject cattle that are over-filled.
9. All steer calves are guaranteed to be steers by the Consignor.
10. Any Consignor who bids on his on direct consigned livestock will run the risk of forfeiting his right to consign livestock in the future.
11. Consignors will be charges 22 cents per head insurance, which will include full coverage for all cattle from the time they leave the farm until they are loaded on the buyer's trucks. Cattle rejected at the dock will not be covered by this insurance.
12. One dollar (\$1.00) per head will be deducted for Indiana Beef Cattle Association.
13. Consignor hereby agrees to leave all decisions concerning the weighing and grading of cattle and order of sale to the management of the Association,
14. Consignor agrees that any liens upon livestock hereby consigned will be fully satisfied and further agrees to indemnify and defend the Association from any claims on account of the sale of the consigned livestock.
